

# Self-Responsible Declaration of the computer billing system

In accordance with the provisions of the Spanish regulations, specifically in Article 13 of the Royal Decree 1007/2023, of December 5, which regulates the requirements for billing systems ('Royal Decree 1007/2023'), and Article 15 of the Ministerial Order HAC/1177/2024, of October 17, which develops the technical specifications for such systems; Zoho Corporation B.V. hereby issues this responsible declaration required for invoicing software producers.

Zoho One provides a fully managed OS, version control, and patch management as part of its SaaS offering. Zoho One is a cloud-hosted SaaS platform; therefore, the underlying operating system is fully managed by Zoho. Customers do not need to manage OS installations, updates, or patches, ensuring consistent and secure operations.

1.d) The hardware and software components of the computer system covered by this declaration of responsibility, together with a brief description of what the computer system does and its main functionalities.

Zoho One is an all-in-one software solution comprising 45+ applications, also offering finance products as part of its suite. These products include Zoho Invoice, Zoho Books, Zoho Inventory, and Zoho Billing.

- Zoho Invoice helps craft detailed quotes and invoices, accept online payment, and automate payment follow-up emails.
- Zoho Books helps simplify online payments and fetches bank feeds, apart from



automating payment reminders for invoices.

- Zoho Billing helps manage all your billing needs—whether it's one-time invoicing, complex subscription scenarios, or tracking payments.
- Zoho Inventory simplifies inventory and order management, right from tracking items to streamlining sales and overseeing warehouses.

## **Integration Details**

Zoho One comprises of finance applications namely - Zoho Invoice, Zoho Inventory, Zoho Billing and Zoho Books. These finance applications comply with the requirements enlisted in Royal Decree 1007/2023 and Order HAC/1177/2024 and includes the necessary technical functionalities to operate as a VERI\*FACTU system. Thanks to its native integration with the B2Brouter API, it enables:

- 1. Issuance of electronic documents with QR codes and hash tokens
- 2. Assurance of integrity and traceability of records
- 3. Assurance of non-modification of records
- 4. Automatic and secure transmission of records to the Spanish Tax Agency (AEAT)
- 1.e) Indication of whether the computer system referred to in this declaration of responsibility has been produced in such a way that, for the purposes of complying with the Regulation, it can only be operated exclusively as 'VERI\*FACTU'.

#### Yes.

The finance applications in Zoho One, namely - Zoho Invoice, Zoho Inventory, Zoho Billing and Zoho Books, are developed for use only as VERI\*FACTU for the purposes of Royal Decree 1007/2023.

1.f) Indication of whether the computer system referred to in the tax return can be used by several taxable persons or by the same user to support the invoicing of several taxable persons, in accordance with the specifications given in section 2.6 of the Annex.

1.g) Types of signature used to sign billing and event records in the event that the computer system referred to in this responsible declaration is not used as 'VERI\*FACTU'.

As the finance applications in Zoho One can only be used exclusively in the 'VERI\*FACTU' mode, there is no express electronic signature of the invoicing records generated. The regulations consider the invoicing records signed, when they are correctly sent to the electronic services of the Tax Agency with due authentication, by means of the appropriate qualified electronic certificate.

- Integrity control of records
- Consolidation into a transactional unit
- Access control and traceability



# Backup and error recovery policies

Through B2BRouter connector, the finance applications namely Zoho Invoice, Zoho Books, Zoho Inventory and Zoho Billing in Zoho One communicates with the tax authorities to send invoice information. In this way, sales invoices are sent to the B2BRouter platform, which then handles clearance with AEAT and delivery to the customer. The finance applications in Zoho One maintain a complete audit trail, starting from the creation of the records through to its transmission to B2BRouter. B2BRouter, in turn, maintains its own audit log for the subsequent steps.
